Any change in enrollment can adjust and/or delay aid disbursement and refund amounts.

Notice 3: The balance/credit shown in the Account Summary and Account Activity views in Self-Service reflects an anticipation of aid and may not reflect a real-time balance or credit on your acount. If you expand the Financial Aid section you can identify if aid has disbursed or is still anticipated. If you click on Payment Options to go to the ePayments site you can verify your real-time balance.
