Candidate Competency at Program Completion

To be classified as a Program Completer and be eligible for licensure, the School of Education requires that candidates successfully complete all program requirements that apply to their licensure program. Once a candidate has completed all of these program requirements, they are classified as a Program Completer and are eligible to be recommended for licensure. By completing these requirements, a candidate has demonstrated that they possess the minimum required level of competency to be considered an entry level teacher. Therefore, to evaluate overall competency at completion, the School of Education seeks to compare the performance of its program completers with that of those across the state in key assessments. To do so, the School of Education compares the competency levels of those completing the Final Candidate Preservice Assessment of Student Teaching (CPAST) Evaluation, as well as the OAE Applied Professional Knowledge Assessments, the OAE Content Assessments, and the OAE Foundations of Reading Assessment, in order to see how they compare to those across the state. From an analysis of these data points, the School of Education is able to evaluate the competency level of completers, providing valuable feedback about areas of strength and improvement within our licensure programs.

Candidate Preservice Assessment of Student Teaching

The Candidate Preservice Assessment of Student Teaching (CPAST) is a formative and summative assessment that was developed by a consortium of 26 EPP's in the State of Ohio and is currently maintained by The Ohio State University. It is distributed within the State of Ohio, as well as across the nation. Franklin University adopted the CPAST for evaluative purposes during the Spring 2018 semester. The CPAST is aligned to CAEP and InTASC standards and is given during the clinical student teaching experience. The assessment is given twice, once as a Midterm and once as a Final evaluation, in order to evaluate candidate growth.

For the purposes of analysis, the School of Education reviews the average scores of the final evaluation for those individuals within the School of Education who have completed their program, as well as of those who completed the assessment within the state of Ohio. The School of Education maintains an internal process for tracking its completers, as well as candidates' CPAST scores. State-wide performance data is obtained from The Ohio State University via a dedicated SharePoint for EPP's who are authorized to utilize the assessment.

Notes: Data is provided for each semester the CPAST was administrated, for comparison purposes, data for the fall and spring of the previous two academic years are provided (data for the fall of the current academic year was not available at the time of reporting). Semester reflects the semester the assessment was completed, not the semester of program completion. Program completion measured as of 03/28/2025. Data in the following table reflects the number of unique individuals evaluated.

OAE Assessments

The Ohio Assessments for Educators (OAEs) assess the content-area and professional (pedagogical) knowledge of candidates who are seeking Ohio educator licensure. OAEs are aligned with Ohio Educator Standards, Ohio Learning Standards, and other professional standards, as appropriate. OAEs are administered by Pearson who reports scores on a monthly basis via the Ohio Assessments for Educators EdReports portal for those who elect to have their results sent to the School of Education. The School of Education maintains an internal process for tracking the performance of individuals who elect to have their results sent to the School of Education, in which score reports are downloaded and entered into a comprehensive dataset for each assessment. This data is then analyzed and used to inform suggestions for program improvements.

Additionally, the School of Education collects and analyzes data on the performance of individuals who complete the OAEs across the state. Test-taker and scoring data are collected from the OAE Test Administration Technical Reports, which have a one-year lag reporting. This data is then used to calculate a weighted average, which is compared to the School of Education's performance, in order to compare the competency level of School of Education completers with all individuals who completed the assessment within the state.

Notes: Year reflects the year the test was completed, not the year of program completion. Both the School of Education and the Ohio statewide results reflect a reporting period from September 1 to August 31 for the reported year. Program completion measured as of 03/28/2025. Data in the following tables reflects the number of unique tests taken
